



**Item 1 – Introduction: Is an investment advisory account right for you?**

Central Valley Advisors, LLC, doing business as O’Brien Wealth Management, is registered with the Securities and Exchange Commission as an investment adviser. Please be aware that brokerage and investment advisory services and fees differ and that it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisers, and investing.

**Item 2 – What investment services and advice can you provide me?**

We offer investment advisory services to retail investors. Our principal services include Portfolio Management Services. Please refer to our Form ADV Part 2A Appendix 1 for information on our services. Our firm is a Sponsor and Manager of a Wrap Fee Program where our portfolio management services consist of continuous and regular supervisory and management services with respect to your account(s). If you open an investment account with our firm, we will monitor your investments on an ongoing basis and will review your account at least annually. We manage investment accounts on a *discretionary* basis where we *will decide* which investments to buy or sell for your account. In our sole discretion, we may accept instructions from you that limit our discretionary authority (for example, limiting the types of securities that can be purchased or sold for your account). We offer advice on most types of investments and products including, but not limited to: equity securities, mutual funds, exchange traded funds, U.S. government bonds, municipal bonds, options, structured notes (publicly traded), and certificates of deposit. Additionally, we may advise you on various types of investments based on your stated goals and objectives. Our firm does not impose requirements for opening and maintaining accounts or otherwise engaging us.

**Item 3 – What fees will I pay?**

We are primarily compensated by a percentage of assets under management fee. Our fees vary depending on the services you receive. Portfolio management fees are based upon a percentage of your assets under our management and are typically payable monthly in arrears based on the average daily balance of your account during the billing period. The more assets there are in your advisory account, the more you will pay in fees. Therefore, we have an incentive to encourage you to increase the assets in your account. Asset-based fees associated with our wrap fee program will include transaction costs and fees to a broker-dealer that has custody of these assets, and therefore are generally higher than a typical asset-based advisory fee. Since our firm pays the transaction costs associated with securities transactions, we have an incentive to minimize the trading in your account; however, as a fiduciary we will always act in your best interest. Our fees are negotiable depending upon the complexity and scope of the service, your financial situation, and your objectives.

**Description of Other Fees and Costs:** The broker-dealer or custodian may also charge your account for custodial fees, retirement account fees, trust fees, exchange fees, redemption fees that may be assessed on investment company shares, transfer fees, account termination fees or other special service fees and charges. The wrap program fee does not include mark-ups and mark-downs, dealer spreads or other costs associated with the purchase or sale of securities, interest, taxes, or other costs, such as national securities exchange fees, charges for transactions not executed through the qualified custodian, costs associated with exchanging currencies, wire transfer fees, or other fees required by law or imposed by third parties. Clients will be responsible for these additional fees and expenses. We do not share in

any portion of these fees imposed by the broker-dealer, custodian or third-party. To fully understand the total cost you will incur, you should review all the fees charged by investment companies, broker-dealers, our firm, and others. **You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.**

*Conversation Starter. Ask your financial professional—*

- ❖ *Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?*

**What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?**

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:

- All investment advisers face conflicts of interest which are inherent in the business. Our source of compensation is through asset-based fees. Therefore, we are financially incentivized to acquire new clients and to increase assets under management.
- Some of our financial professionals are insurance agents, which creates a conflict of interest because these individuals will receive additional commission-based compensation in connection with the purchase and sale of insurance products. You are not required to purchase insurance or securities from our financial professionals.

**How do your financial professionals make money?**
